CITY OF MELVILLE BYLAW NO. 07/2022

A BYLAW OF THE CITY OF MELVILLE, SASKATCHEWAN TO EXEMPT CERTAIN NON-PROFIT PROPERTY AND/OR COMMERCIAL PROPERTY FROM TAXATION FOR THE YEAR 2022

WHEREAS, Section 262 of *The Cities Act* authorizes a Council to pass a bylaw exempting any property from taxation for the current year in whole or in part as designated in the bylaw.

WHEREAS, Section 262 (3) and (4) of *The Cities Act* authorizes a Council to exempt any property from taxation for the current year in whole or in part as designated in the bylaw;

AND WHEREAS, Section 263 (2) and (3) allows for the exemption to be applied to the other taxing authorities and the actions to be taken in that case;

AND WHEREAS, the Melville City Council desires to exempt certain Non-Profit Property and/or Commercial Property from Taxation for the Year 2022;

AND WHEREAS, the Melville City Council has by resolution set certain policies as an incentive to commerce and industry to locate in the City of Melville;

AND WHEREAS, the other taxing authorities, namely the respective school division has agreed to this exemption;

THEREFORE BE IT RESOLVED THAT the following property taxes be exempted to the extent as set out below:
